**NOTICE TO GARNISHEE: YOU ARE THE GARNISHEE IN THE ABOVE ACTION.**

You must complete and file the enclosed Answer form within thirty (30) days from service of process. If you fail to file an Answer, the Plaintiff can proceed for judgment against you for the amount of the claim, plus costs. Mailing the Notarized Answer Form to the Clerk of the Court at the address below constitutes making a proper appearance in the Court. **YOU MUST ANSWER:** (1) whether you are or were indebted to the Defendant at the time you received this process, or when you make your answer, or during the intervening time, or (2) whether you will be indebted to the Defendant in the future by existing contract, or (3) whether by existing contract you are liable to the Defendant for the delivery of personal property or for the payment of money, or (4) whether you have in your possession or control, money or effects belonging to the Defendant. You are commanded to retain the amount indicated above of wages, salary, or other compensation due or which will become due to the Defendant from such period of time as is necessary to accumulate the sum of \$1143.00 (judgment and costs).

**You are required, after a period of 30 days from the first retention of any sum from the Defendant's wages, salary, or other compensation, to begin paying the moneys withheld into court as they are deducted or withheld and continue to do so on a monthly or more frequent basis until the full amount is withheld.**
